

RIDER "THE EIGHT" SCORE REPORT FORM

Reminders: Score report form must be completed, scores validated, and forms submitted by the rider.

Incomplete/illegible forms will NOT be accepted.

Score Requirements

- Eight (8) scores of '8'.
- Marks considered are the collective marks on a test for Rider's Position and Seat or Rider's Correct and Effective Use of the Aids.
- If a rider receives a score of '8' for both collective marks, both scores will count towards the "Eight" achievement pin
- Can be accumulated from 2022 onward. There is no set timeframe (can be over several seasons).
- A minimum of two different shows are required (scores cannot all be from the same show).
- Freestyle scores will <u>not</u> be considered.

Scores can be achieved with different horses and can be from EC Gold and/or Platinum (FEI) sanctioned competitions.

A separate score report form is needed for each test.
