



HACKNEY JUDGE

1 PROMOTION

All applications for Hackney judges' status must be made on the application form available from EC and must be submitted to EC, with all required documents. All applications will be reviewed by EC and the Canadian Hackney Society. The applicant will be advised in writing by EC as to the results.

2 RECORDED

Applicants for Recorded Hackney judge status must:

1. Hold an EC individual Gold sport license and Canadian Hackney Society membership and be in good standing.
2. Submit a personal resume detailing the applicant's equine experience as owner, breeder, trainer, competitor, competition manager.
3. Act as a learner judge with a senior EC or USEF American Hackney judge listed on their current Officials' Roster, at a minimum of two EC national competitions in the American Hackney Division; and must obtain letters of recommendation from these two Senior EC or `R` American Hackney judges which must accompany the application.
4. Provide the names and addresses of three or more individual references, all of whom must be EC or USEF individual senior sport license holders.
5. Recorded Hackney judges are encouraged to attend an EC or USEF recognized judges' clinic at least once every five year although this is not mandatory.

3 SENIOR

Applicants for Senior Hackney judge status must:

1. Be an EC Gold sport license holder and Canadian Hackney Society member in good standing.
2. Fulfill the requirements of either Part One or Part Two below:

Part One – Hackney Division

- a. Hold an EC recorded judge's card in the Hackney Division prior to being approved for senior judge's status in the Hackney Division.
- b. Have acted as a recorded judge for the Hackney Division at a minimum of five EC or USEF competitions.
- c. Submit a list of competitions at which she/he worked as a recorded judge in the Hackney Division; a list of the classes worked in each competition; if possible the number of horses/ponies in each class; and the names and addresses of the senior judge(s).
- d. Submit two letters of recommendation from EC senior USEF `R` Hackney judges listed on their current Officials' Roster with whom the applicant acted as a recorded judge (not learner judge experiences) in the Hackney Division in the above noted five EC or USEF competitions.

OR

Part Two – Hackney Division



- a. Upon approval of the Canadian Hackney Society, a candidate may request and be granted Senior Judge Status without having been a Recorded Judge with the following provisions;
- b. The candidate must provide 5 letters of reference from either Senior EC judges and or USEF `R` judges.
- c. The candidate should also provide a resume outlining their relevant experience as a judge, owner, trainer breeder
- d. Approval will be granted by the Canadian Hackney Society.

4 REINSTATEMENT & MAINTENANCE

A judge may be reinstated upon approval of the Canadian Hackney Society. To maintain a card, a judge must keep their EC Sport License and Canadian Hackney Society Membership in good standing.
