

SADDLESEAT EQUITATION JUDGE

1 PROMOTION

All applications for Saddle Seat Equitation judge status must be made on the Saddle Seat Equitation application form available from EC and must be submitted to EC. All applications will be reviewed by Equestrian Canada. The applicant will be advised in writing by EC as to the results.

2 RECORDED

An applicant for Recorded Saddle Seat Equitation judge status must:

- 1. Be an EC individual Gold Sport License holder in good standing.
- 2. Submit a personal resume detailing the applicant's equine experience, i.e. as owner, breeder, trainer, competitor, competition manager.
- 3. Act as a learner judge with an EC Senior or USEF Registered Saddle Seat Equitation judge listed on their current Officials' Roster, at a minimum of two EC-sanctioned competitions in the Saddle Seat Equitation Division; and must obtain letters of recommendation from these two EC Senior and/or USEF Registered Saddle Seat Equitation judges, which must accompany the application.
- 4. Have attended an EC or USEF Saddle Seat Equitation judges' clinic.
- 5. Provide the names and addresses of three or more individual references, all of whom must be EC Gold Sport License holders.
- 6. Write the EC Saddle Seat Equitation Test, which is available from EC, and obtain the required passing score.

Note: Test will be given to the applicant when all other requirements are met.

3 SFNIOR

An applicant for Senior Saddle Seat Equitation judge status must:

- 1. Hold an EC individual Gold Sport License.
- 2. Hold an EC Recorded judge's card in the Saddle Seat Equitation Division prior to being approved for senior judge's status in the Saddle Seat Equitation Division.
- 3. Have acted as a Recorded judge for the complete Saddle Seat Equitation Division at a minimum of five EC competitions. Recorded Judging in foreign countries will be accepted provided a letter signed by the senior judge or show steward verifying attendance accompanies the application.
- 4. Submit a list of competitions at which she/he worked as a Recorded judge in the Saddle Seat Equitation Division; a list of the classes worked in each competition; if possible, the number of competitors in each class; and the names and addresses of the senior judge(s)
- 5. Submit two letters of recommendation from EC Senior and/or USEF Registered Saddle Seat Equitation judges listed on their current Officials' Roster with whom the applicant acted as a Recorded judge (not learner judge experiences) in the Saddle Seat Equitation Division in the above noted five EC competitions.
- 6. Have attended an EC or USEF Saddle Seat Equitation judges' clinic.
- 7. Write the EC Saddle Seat Equitation Test, which is available from EC, and obtain the required passing score.

Note: Test will be given to the applicant when all other requirements are met.
