

## 8 The classes, or regional or other groups, of members that the corporation is authorized to establish

The Corporation shall have three categories of membership, to be designated as Category A (Equestrian Sports), Category B (Provincial and Territorial Sport Organizations) and Category C (National Equine Organizations). Each category is authorized to designate up to nine (9) delegates to be Members and each Member shall be entitled to one vote. The by-laws of the Corporation shall provide (i) the conditions for membership in each category, (ii) the manner of withdrawing from a category or transferring membership to another category and any conditions of transfer, and (iii) the conditions on which membership in a category ends.

## 9 Statement regarding the distribution of property remaining on liquidation

In the event of the dissolution or winding-up of the Corporation, all of its remaining assets after the payment of its liabilities shall be distributed to one or more qualified donees within the meaning of Subsection 248(1) of the Income Tax Act (Canada) for use for the benefit of equestrian activities in Canada, consistent with the Mission Statement and Objects of the Corporation. Specific distribution to one or more qualified donees will be determined by the Board.

# THIS IS SCHEDULE "A" REFERRED TO IN THE FOREGOING ARTICLES OF EQUINE CANADA

### SECTION 6 - STATEMENT OF PURPOSE

#### OBJECTS OF EQUINE CANADA

- 1. The aims and objectives of EQUINE CANADA (in this Section I, the "Corporation") are:
  - (a) To act as the national governing body for equine and equestrian sporting and recreational activities and interest (except racing) in Canada.
  - (b) To promote, further, improve, guide, co-ordinate the activities of, provide administrative leadership and develop and provide administrative services to and information for all equine and equestrian sporting and recreational activities, organizations, and interests in Canada and to operate, function and act 'in any way which the Corporation considers beneficial to the equine and equestrian interests in Canada.
  - (c) To provide a democratic and unified representation on behalf of its members and to act on their behalf in all matters on the international and national level, and, where no Provincial Organization has been developed and recognized, to encourage the development and recognition of such Provincial Organization and in the meantime to represent and act on behalf of its members in all matters on the Provincial and local level.
  - (d) To establish affiliation with all international Equestrian Associations that act as governing bodies for equine sporting and recreational activities throughout the world such as the Federation Equestre Internationale ("F.E.I") and to act as the sole national authority in all matters concerned with the F.E.I., including the authority to nominate representatives to the General Assembly of the F.E.I.
  - (e) To encourage and develop horses, riders and drivers to represent Canada at International Competitions.
  - (f) To be responsible for dealing on policy matters with any other National Federation.
  - (g) To encourage and promote the interests of horse shows and exhibitors in Canada and, without limiting the generality of the foregoing, specifically:
    - (i) To adopt upon incorporation the Rules of the National Equestrian Federation of Canada - Canadian Horse Shows Association as the National Rules of EQUINE CANADA and thereafter to continue to develop, improve, maintain, promulgate and enforce uniform national rules governing the conduct of all- equestrian activities, exhibitions and competitions recognized by the Corporation; racing excepted;
    - (ii) To recognize and/or appoint judges, stewards and technical delegates and to promote the education of aspirants to such offices;
    - (iii) To adjust and arbitrate disputes which may arise between members in any category or between members of different categories.
  - (h) (i) To encourage and promote knowledge in the care, handling and enjoyment of horses and in the science of horsemanship and equitation by:
    - 1. developing standards by which those teaching horsemanship and equitation may be graded and recognized;
    - 2. developing standards by which equestrian teaching establishments and boarding stables may be graded and accredited by the Corporation.

- 3. encouraging the establishment of schools of instruction in horsemanship and equitation at universities, colleges and other institutions of learning, and by establishing such schools of instruction.
- (ii) To make available all pertinent information on equestrian activities, to publish rule books, manuals and pamphlets promoting the knowledge of the art of riding, horsemanship, breeding, and the welfare of horses and ponies.
- (i) To foster and encourage the breeding, training, preservation and protection of all equines, both domestic and feral, and the interests of any individual or organization whose aims and objects include the welfare of equines, whether for pleasure, competition or as a professional or business activity.

#### SECTION 10 - ADDITIONAL PROVISIONS

#### II. MEETING OF MEMBERS OUTSIDE CANADA

 A meeting of the members may be held outside of Canada at the place determined from time to time by the directors.

#### III. LIEN ON MEMBERSHIPS

EQUINE CANADA shall have a lien on a membership registered in the name of a member or the
member's personal representative for a debt of such member to EQUINE CANADA, including in
respect of annual contributions or annual dues payable to EQUINE CANADA. EQUINE CANADA
may enforce such lien in accordance with the by-laws of EQUINE CANADA.

#### IV. OTHER MATTERS

- Subject to the sentence which follows, no part of EQUINE CANADA's profits or of its property or accretions to the value of such property may be distributed, directly or indirectly, to a member, a director or an officer of EQUINE CANADA except in furtherance of its activities or as otherwise permitted by the Act. If a member is an entity that is authorized to carry on activities on behalf of EQUINE CANADA, EQUINE CANADA may distribute any of its money or other property to the member to carry on those activities.
- If EQUINE CANADA is deemed to be a "soliciting Corporation" under the Act, at all times at least two (2) of the directors of EQUINE CANADA must not be officers or employees of EQUINE CANADA or its affiliates.
- 3. The directors of EQUINE CANADA may appoint one or more additional directors to hold office for a term not later than the close of the next Annual Meeting (as defined in EQUINE CANADA's By-Laws) of members, but the total number of additional directors so appointed shall not at any time exceed one-third (1/3) of the number of directors elected at the previous annual meeting of members. The precise number of directors to be appointed in this manner may be fixed by ordinary resolution of the members.
- 4. Other than indemnification for expenses incurred on behalf of EQUINE CANADA in their capacities as directors and/or officers of EQUINE CANADA and reasonable per diems while traveling on corporate business (the amount of which such per diems shall be set by the directors of EQUINE CANADA from time to time), the directors and the officers of EQUINE CANADA shall not be entitled to any remuneration for serving as such.
- 5. Each category of membership shall not be entitled to vote separately as a Category on a proposal to make an amendment referred to in Section 199(1) of the Act to (i) effect an exchange, reclassification or cancellation of all or part of the memberships of the Category or (ii) create a new Category of members having rights equal or superior to those of the Category.


