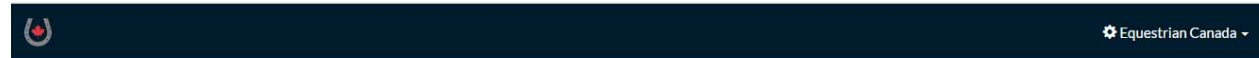

Dear Athlete,

Equestrian Canada has responded to the demand for an easier way for athletes to provide their application for FEI competitions outside of Canada. Here is an introduction to the new online portal. This portal will be accessible to athletes by computer, smartphone or iPad devices.

Please review the below information to familiarize yourself with the functionality of the online portal. We appreciate any feedback you wish to provide as you begin to use this system. Please contact the Jumping Department directly if you experience any difficulties with this portal.

- 1. You will need your EC sport licence number and password to login. If you do not have a platinum sport licence you will receive a message directing you to upgrade or renew your licence requirements. Athletes must apply to Equestrian Canada using this application form in order to compete in any CSI and CSIO competition outside of Canada. The application must be received no later than 10 business days prior to the start of the event.

- The athlete must be a Canadian citizen who holds a current Platinum EC Sport License in good standing;
- All horses must be current and up to date with the owner's National Federation and hold a valid FEI passport;
- Athlete and horse(s) must be registered with the FEI for that year;
