

2026 FEI WORLD CHAMPIONSHIPS AACHEN EQUESTRIAN CANADA SELECTION CRITERIA & PROCEDURES -

EVENTING

1. INTRODUCTION

- 1.1 The purpose of this document is to set out the selection criteria and procedures ("Selection Criteria") that the Eventing High Performance Selection Committee will use to select athlete/horse combinations to compete at the 2026 FEI World Championships Aachen ("2026 WC") for Eventing, scheduled for August 13 16, 2026.
- 1.2 Discipline-specific selection criteria are outlined in *Appendix 1*. Questions specific to the Selection Criteria should be directed to the Chair of Eventing, High Performance, <u>Dr. Emily Gilbert</u> at: <u>egilbert@equestrian.ca</u> ("Eventing High Performance Chair").
- 1.3 Athlete/horse combinations must meet the expectations outlined in these Selection Criteria to be considered for selection.
- 1.4 Athletes and owners who choose to participate in the selection process acknowledge by their participation and declaration that meeting the requirements outlined in these Selection Criteria does not guarantee that an athlete/horse combination will be selected.
- 1.5 It is important for the integrity of the selection process that athletes, grooms, owners, team support personnel and associated parties involved in the selection process, practice at all times a high degree of confidentiality relating to information which may have a bearing on selection, and/or any selection decisions. All confidential information, conversations, and discussions will be identified as such. Any person who breaks this confidentiality may be removed from the selection process.
- 1.6 If there is a difference in interpretation between this document's French and English versions, then the English version shall prevail.
- 1.7 Any intentional misrepresentation of information submitted for selection consideration may, at the sole discretion of the EC Eventing High Performance Advisory Group ("HPAG"), eliminate the athlete/horse combination from both the qualifying process and consideration for selection.

2. ELIGIBILITY

To be eligible for selection consideration for the 2026 WC, the following minimum eligibility requirements listed in this section must be met:

2.1 Athlete

- Be a Canadian citizen at the time of declaration and until the conclusion of the 2026 WC
- Have a Canadian passport that is valid until at least **November 23, 2026**



- Meet the European Union's travel requirements that are in place at the time of the championships, including the <u>European Travel Information and Authorization System</u> (ETIAS) and meet the European Union's <u>Entry/Exit System</u> (EES)
- Be eligible to travel to any required quarantine/training camp and the 2026 WC
- Be in compliance with all relevant International Federation ("FEI") requirements for eligibility
- Be a member in good standing (Platinum Sport Licence Holder) with EC
- Hold a current FEI Registration and be in good standing with the FEI
- Sign and submit the Equestrian Canada ("EC") Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - Safe Sport policies
 - o <u>The Universal Code of Conduct to Prevent and Address Maltreatment in Sport (UCCMS)</u>
 - o Canadian Safe Sport Program, as applicable
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines, including for the <u>Canadian Anti-Doping Program ("CADP")</u>
- Meet minimum athlete age requirements as per the 2025 FEI Regulations and be 18 years of age in 2026, born on or before December 31st, 2008

2.2 Horse

- Meet minimum horse age requirements as per the <u>2025 FEI Regulations for Equestrian Eventing</u> Competitions and be 9 years of age in 2026, born on or before December 31st, 2017
- Possess a valid FEI Horse Registration document (passport) and be in good standing

2.3 Groom

- Be a minimum of 18 years of age at the time of the 2026 WC
- Have a passport that is valid until at least November 23, 2026
- Meet the European Union's travel requirements that are in place at the time of the championships, including the <u>European Travel Information and Authorization System</u> (ETIAS) and meet the European Union's <u>Entry/Exit System</u> (EES)
- Be eligible to travel to any required quarantine/training camp and the 2026 WC
- Have experience competing or grooming at international equestrian competitions
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines
- Must sign and submit the EC Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - Safe Sport policies
 - The Universal Code of Conduct to Prevent and Address Maltreatment in Sport ("UCCMS")
 - o <u>Canadian Safe Sport Program</u>, as applicable

2.4 Owner

- Have a valid passport until at least November 23, 2026
- Meet the European Union's travel requirements that are in place at the time of the championships, including the <u>European Travel Information and Authorization System</u> (ETIAS) and meet the European Union's <u>Entry/Exit System</u> (EES)
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines



- At minimum one owner must be listed as an owner in the FEI horse passport unless the horse is owned by a syndicate
- Must sign and submit the EC Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - Safe Sport policies
 - o <u>The Universal Code of Conduct to Prevent and Address Maltreatment in Sport (UCCMS)</u>
 - o <u>Canadian Safe Sport Program</u>, as applicable

2.5 Support Team Members

- Have a passport that is valid until at least November 23, 2026
- Meet the European Union's travel requirements that are in place at the time of the championships, including the <u>European Travel Information and Authorization System</u> (ETIAS) and meet the European Union's Entry/Exit System (EES)
- Be eligible to travel to any required quarantine/training camp and the 2026 WC
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines
- Must sign and submit the EC Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - o Safe Sport policies
 - o <u>The Universal Code of Conduct to Prevent and Address Maltreatment in Sport</u> (UCCMS)
 - o <u>Canadian Safe Sport Program</u>, as applicable

2.6 Athlete Companion (should accreditation be available)

- Have a passport that is valid until at least **November 23, 2026**
- Meet the European Union's travel requirements that are in place at the time of the championships, including the <u>European Travel Information and Authorization System</u> (ETIAS) and meet the European Union's Entry/Exit System (EES)
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines
- Must sign and submit the EC Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - Safe Sport policies
 - The Universal Code of Conduct to Prevent and Address Maltreatment in Sport (UCCMS)
 - o Canadian Safe Sport Program, as applicable

3 DECLARATION AND ACCREDITATION PROCEDURES Declaration

- 3.1 Deadline Date: Athletes must submit a declaration for the 2026 WC to EC through the EC Games Portal on or before 12 midnight ET, January 7, 2026. Failure to submit the required information and documents by this deadline will make the declaration incomplete and invalid. No late declarations will be accepted, except for already declared athletes in accordance with Section 3.8.
- Purpose: The declaration deadline allows sufficient time for the Accreditation Process to be completed for athletes, grooms, owners, and support team personnel.



- 3.3 **Process:** The declaration MUST be made through the EC Games Portal at:
- New Users https://licence.equestrian.ca/gamesdb/register?user=new
- Existing Users: https://licence.equestrian.ca/gamesdb/login.aspx
- 3.4 **Fees**: No declaration fees will be charged for declarations for the Eventing discipline.

At the time of declaration, the athlete MUST provide:

- 3.5 **Horses**: The name, FEI passport number, and FEI passport expiry date for each declared horse. *Please refer to Section 2.2 for horse eligibility*.
- 3.6 **Grooms**: The name, **unique e-mail address**, and phone number for a minimum of two (2), up to a maximum of four (4), declared grooms in priority order. Athletes are responsible for ensuring that their groom is eligible (*please refer to Section 2.3 for groom eligibility*), kept informed, and available for the time commitments in the proposed schedule for 2026 WC (an expected four-week commitment which includes any potential staging camp period). Should a groom not carry out their assigned duties and obligations or exhibit inappropriate behavior detrimental to the team, then EC has the authority to remove such groom from the team. *Please refer to Section 2.3 for groom information*.
- 3.7 **Owners:** The name, **unique e-mail address**, and phone number for up to two (2) declared owners per horse, in priority order for accreditation purposes; at least one owner must be listed in the IF horse passport. In the case of syndicate ownership groups, declared athlete/horse owners do not need to be individually listed in the FEI horse passport, but must be individually declared in priority for accreditation purposes. *Please refer to Section 2.5 for owner eligibility*.
- 3.8 **Declaration Date Exception:** Except as set out in this **Section 3.8**, athletes may not submit a declaration after the **12 midnight ET, January 7, 2026** deadline.
 - 3.8.1 In the case of a horse being made available to an already declared athlete after the declaration deadline to form a "New athlete/horse combination", EC may, in its sole discretion, accept this athlete/horse combination as a declared candidate for the 2026 WC.
 - 3.8.2 Additional athlete/horse combinations must be submitted in writing to the Eventing High Performance Chair at the earliest date possible, and no later than **March 30th, 2026**.
 - Note 1: Horse owner accreditation may not be possible for new horses declared after <u>12</u> midnight ET, January 7, 2026 deadline.
 - **Note 2:** "New athlete/horse combination(s)" are defined as either a:
 - o new horse purchase, or
 - o horse transfer to an already declared athlete.

Withdrawal: Declared athletes who subsequently choose to withdraw from the selection process (either themselves or their horse) prior to the naming of the team and alternates, must advise the Eventing High Performance Chair, <u>Dr. Emily Gilbert</u> at: egilbert@equestrian.ca,



Accreditation

- 3.9 **Process**: The accreditation process for the 2026 WC will be coordinated through EC. To help facilitate this process, the athletes' declaration in the EC Games Portal must include the **personal/unique e-mail addresses** and phone numbers for all potential grooms and owners. Any subsequent changes to accreditation details i.e. new owners, grooms etc., must be reported promptly to the Eventing High Performance Chair in writing. **Athletes, grooms, owners, and team personnel are not permitted to apply directly to the Aachen OC for accreditation**.
- 3.10 **Allocation**: EC has the exclusive authority to, select, and allocate accreditations for the grooms, lungers, owners, and team personnel who comprise the Canadian Equestrian Team ("CET") to represent Canada at the 2026 WC. Accreditations for 2026 WC are limited and are allocated based on the needs of the entire team and on what the HPAG decides will lead to the best team performance at the 2026 WC.
- 3.11 **Information Deadline**: Athletes, grooms, owners, and team support personnel are to provide all necessary accreditation information, including photos and passport details and personal information, in the EC Games Portal by the declaration deadlines outlined in *Sections 3.1* and *3.8* above.
- 3.12 **Declared list:** It is very important that information is provided and entered in the EC Games Portal for EVERY possible individual who may attend the 2026 WC in an accredited role (Athlete, Owner, Groom, Team Personnel, etc.) prior to the declaration deadline referenced in **Section 3.11**. Participation in this process does not guarantee accreditation nor selection.

Release of Liability Waiver

- 3.13 All selected athletes and their applicable grooms, lungers, owners and team personnel, must complete, sign and return their release of liability waivers to the Eventing High Performance Chair within 7 days following notification of selection decisions in July. The waiver and release forms can be found in the following appendices.
 - Appendix 2: Athlete Release of Liability, Waiver of Claims, Assumption of Risk, and Indemnity Agreement
 - Appendix 3: Groom/ Team Personnel Release of Liability, Waiver of Claims, Assumption of Risk, and Indemnity Agreement
 - Appendix 4: Owner Release of Liability, Waiver of Claims, Assumption of Risk, and Indemnity Agreement

4 ANTI-DOPING HUMAN AND EQUINE

<u>Athlete</u>

- 4.1 **Eligibility**: The athlete must not be under suspension or any other sanction by any recognized body for any doping or doping-related offense.
- 4.2 **Testing**: Declared athletes may be subject to announced and unannounced drug testing in accordance with the <u>CADP</u>. Testing includes both in-competition and out-of-competition testing. All athletes who declare for the selection process must provide accurate and up-to-date contact information through the EC Sport Licence portal.
- 4.3 **Deemed Violation**: Athletes who do not provide up-to-date contact information or respond to EC communications, will be considered in violation of these policies. Violations will be considered in context by the HPAG and may result in the disqualification of the athlete from the selection process.



Horse

- 4.4 **Testing**: All declared horses shall be subject to drug testing according to FEI drug and medication rules. Blood, and/or urine, or any other sampling method as instituted by the FEI, may be drawn at any time throughout the qualification, selection and quarantine/training camp periods. Samples may be tested for the presence for any prohibited and/or controlled substances by the FEI.
- 4.5 **Prohibited Substances**: In the event a prohibited substance is detected, the amount of this substance will be quantified where possible and reported to the Eventing High Performance Chair. Any horse whose sample contains a prohibited substance or a restricted substance in a concentration greater than the allowable FEI limits may be eliminated from the selection process. Positive test results from samples collected during FEI competition will result in disqualification of that athlete/horse combination in all classes at that competition.

5 APPEALS

- 5.1 **Grounds**: Athletes participating in the selection process for the 2026 WC have the right to appeal against a selection decision but only on the grounds that the HPAG has failed to comply with the correct procedures outlined in the Selection Criteria or has made a patently unreasonable decision based on the Selection Criteria. An appeal must be made in writing to the Independent Third Party Complaint Manager within 72 hours of the relevant athlete being informed of the decision. Appeals must be accompanied by an administration fee of \$1,000.00 (CAD) as per the published EC Schedule of Fees, unless waived by EC, in its sole discretion, as set out in s. 74 of the Discipline, Complaints, and Appeals Policy approved April 14, 2025. The EC Discipline, Complaints and Appeal Policy can be found here.
- 5.2 **Process**: In recognition of the short timelines required for the selection decision process, any appeals to decisions made under the Selection Criteria will proceed under the Sport Dispute Resolution Centre of Canada ("SDRCC") appeal process. The administration fee referred to in *Section 5.1* will be applied to the fee required for the appeal to SDRCC.

6 AMENDMENTS TO THE SELECTION CRITERIA

- 6.1 The Selection Criteria are based on applicable FEI regulations, conditions and restrictions as currently known and understood, and on the latest information available to EC for <u>Eventing</u> by the FEI.
- 6.2 Any changes in the Selection Criteria necessitated by a change in FEI regulations will be distributed via email to the declared athletes as soon as reasonably possible. Should such a circumstance occur, EC will review and may amend Selection Criteria to comply with the new regulations or conditions. Any amendments to this document will be communicated directly to all declared athletes via email. Communication will be sent to the email address provided in the EC Games portal.
- 6.3 Further, situations may arise that do not allow this Selection Criteria to be modified or applied as written due to time constraints or other exceptional and unforeseen circumstances. In such situations, any decision, including selection decisions, will be made by the individual(s) with decision-making authority, as stated in this Selection Criteria, in consultation with the relevant individual(s) including but not limited to the EC Director of High Performance, Veterinary specialists, EC legal representative, the Eventing High Performance Advisory Group, the EC Secretary General or other experts deemed relevant to the determination of selections, and will be made in accordance with the stated performance objectives and selection philosophy and approach as stated herein. Should it be necessary to make any decision in this manner, EC will communicate with all declared athletes as soon as possible.



DISCIPLINE SPECIFIC CRITERIA: EVENTING

1. INTRODUCTION

This Appendix sets out the discipline specific criteria and processes for selecting athletes and horses for the 2026 FEI World Championships to be held in Aachen, Germany from August 13-16, 2026 ("2026 WC"). The discipline specific criteria form a part of the Selection Criteria.

The discipline specific criteria have been compiled in consultation with Equestrian Canada ("EC") and the EC Eventing High Performance Advisory Group ("HPAG").

2. OVERALL CRITERIA OBJECTIVES

- 2.1 The objectives of the discipline specific criteria are as follows:
 - (a) **Primary objective:** To achieve a top 7 team placing at the 2026 WC as a qualification for the 2028 Olympic Games.
 - (b) Secondary objective: To achieve as many top individual placings as possible.
- 2.2 To achieve the primary and secondary objectives of the criteria, the Selection Panel will select based on the criteria outlined in *Section 9* of *Appendix 1*: SPECIFIC SELECTION CRITERIA.
- 2.3 There is no obligation on EC or the Selection Panel to nominate any athlete/horse combinations to compete at the 2026 WC.

3. SELECTION PANEL

The selection panel shall be comprised of three members ("Selectors" or "Selection Panel").

The Selection Panel for the 2026 WC is as follows:

- 1. Bruce Mandeville, Chair
- 2. Bruce Haskell
- 3. Bonnie Mosser

The role, responsibilities and duties of the Selection Panel are described in *Appendix 5* of the Selection Criteria.

The **Eventing High Performance Chair** (Dr. Emily Gilbert) and **EC Director of High Performance** (James Hood), shall assist the Selection Panel in the execution of its duties, each in an *ex-officio* position.

The **Team Veterinarian** (Dr. Alan Manning) will provide further assessment in the selection process as described in *Appendix 1, Section 8* of the Selection Criteria.

In making their decisions, the Selection Panel will consult the EC Eventing **Chef D'Equipe** (Rebecca Howard), but the Chef D'Equipe will not have a vote in selection.



Should a Selector need to be replaced for any reason, e.g. conflict of interest, the HPAG will nominate a replacement to the EC **CEO** (Meg Krueger) who meets the criteria of the job description laid out in *Appendix 5* of the Selection Criteria.

In selecting the combinations for the 2026 WC, it is understood that the individual Selectors may be in a real or a perceived conflict of interest position. Selectors with a conflict of interest shall declare their conflict of interest (real or perceived) in advance. Any member of the Selection Panel who has declared a conflict of interest will remove themselves from all discussions and will abstain from voting in connection with such conflict, including consideration of any family member (direct relatives), business affiliates or any other real or perceived conflicted situation or conflicted relationship that may arise.

4. TECHNICAL SPECIFICATIONS OF THE FEI WORLD CHAMPIONSHIPS EVENTING COMPETITION

In accordance with the Overall Criteria Objectives outlined above (Section 2), Selectors acknowledge the technical specifications of the 2026 WC Eventing Competition:

FEI Regulations for Equestrian Events at the 2026 WC

• **Dressage Test:** CCI5* (Test TBD)

Cross Country Test: Hybrid between CCI4*-L and CCI5* (Approximately 10min, with 38-42 efforts)

• Team Jumping Test: CCI5*

5. KEY TIMELINES:

6. ELIGIBILITY REQUIREMENTS FOR SELECTION CONSIDERATION

6.1 **Priority:** Preference will be given to selection of an eventing team ("**Team**") for the 2026 WC. A Team will consist of 3 or 4 members. An additional individual athlete/horse combination may also be chosen to compete as part of the CET. If a Team does not qualify for the 2026 WC, up to two individual athlete/horse combinations may be selected. Only those athlete/horse combinations achieving at least the minimum eligibility requirements in **Section 6.2** will be considered for selection.

MINIMUM ELIGIBILITY REQUIREMENTS

6.2 **Minimum Eligibility Requirements** –All athletes/horses who take part in the 2026 WC Eventing Competitions, must achieve the following minimum eligibility requirements (MERs) as a combination by obtaining "FEI qualifying results and EC qualifying results" as follows.

The minimum performance standards for consideration for the 2026 WC are below. Athlete/horse combinations that do not meet these criteria will **NOT** be considered for selection as members of the CET.

Within the qualifying period between January 1, 2025 and June 22, 2026 (Qualifying Period), the athlete/horse combination must:



- **Step 1:** Start a minimum of any combination of at least three FEI competitions at the CCI 5*, CCI 4* L, CCI 4* -S level (with at least one of these being a CCI4*-L or CCI5*).
- **Step 2:** Of all FEI competitions at the CCI 5*, CCI 4* L or CCI 4* -S level, an MER performance result has to be achieved in a minimum of 50% of competitions within the Qualifying Period by the athlete/horse combination.
- **Step 3:** a) Achieve a Target Performance Result as outlined in the chart below based on either final Score <u>OR</u> HPR¹ at a minimum of one of the eligible FEI CCI4*-L or CCI5* competitions within the Qualifying Period as set out below.

| Eligible FEI Competition | Target Performance Result (Score) | Target Performance Result (HPR) |
|--------------------------|-----------------------------------|------------------------------------|
| CCI 5* - L | MER | MER |
| CCI 4* - L | 50 or better | 75 or better |

- 6.3 **Declaration:** In order to be considered for selection, athletes must submit their declaration through the EC Games Portal on or before the declaration deadline of **January 7, 2026**, as outlined in **Section**
- 6.4 Competition and Training Plan: Athletes declaring for selection consideration for the 2026 WC are requested to submit their 2026 competition plan to the Chef D'Equipe by January 13, 2026.

This competition plan should include the following:

- Eventing competitions to be attended in 2026, including venue and level of competition
- Personal coach and veterinarian contact information

7. RESPONSIBILITIES

- 7.1 It is the sole responsibility of each athlete to ensure that they have achieved the required **FEI and Canadian MER for eligibility for the 2026 WC**. Please note that the achievement of the minimum eligibility requirements in no way confers an obligation upon EC to select an athlete / horse combination.
- 7.2 **Rule Responsibility:** It is each athlete's responsibility to be fully aware of the current EC Rules & Policies, FEI Rules for Eventing, and the FEI Clean Sport Policy.
- 7.3 **Compliance Responsibility:** Athletes must strictly abide by the following:
 - 7.3.1 FEI General Regulations and FEI Discipline Sport Rules
 - 7.3.2 FEI Code of Conduct for the Welfare of the Horse
 - 7.3.3 FEI Equine Anti-Doping Rules and Equine Controlled Medication Rules

¹ High Performance Rating (HPR): HPR is an Algorithm that allows for comparison of results around the world. This rating considers the competition quality, difficulty and variance in scoring conditions at each individual event on a given day/period.



- 7.3.4 Human Anti–Doping Rules as set out by the FEI and Equestrian Canada
- 7.3.5 Equestrian Canada Rules and Policies
- 7.3.6 Equestrian Canada Code of Conduct
- 7.3.7 Prompt communications with the High Performance Eventing Team personnel
- 7.3.8 Athletes must show a commitment to personal fitness and professional behaviour
- 7.3.9 All athletes selected will be required to wear the official Team Canada clothing and are strongly encouraged to use all sponsored equine apparel on the field of play

8. VETERINARY

- 8.1 **Team Veterinarian Communications**: Throughout the selection process, observations and concerns identified by the Team Veterinarian will be communicated to the athlete of the horse, the owner of the horse, and the Selection Panel. The goal of this communication is first to ensure the well-being of the horses and, secondly, to ensure the best possible performance result. The athlete will be responsible for ensuring recommendations of the Team Veterinarian are followed. Athletes are expected to facilitate open communication between the Team Veterinarian and their personal veterinarians.
- 8.2 **Evaluations of Horses**: To be considered for selection as a definite sport entry or alternate, athletes must make their declared horses available for veterinary evaluations. Evaluations will be conducted by the Team Veterinarian and coordinated with individual athletes at 'to be determined' venues prior to and following the selection decision. Prior to selection, the Team Veterinarian will provide a report to the Selection Panel. The Team Veterinarian's advice will be taken into consideration during selection discussions.
- 8.3 **Final Evaluation of Horses:** Prior to the departure of the horses for the 2026 WC (definite sport entry horses and travelling alternates), veterinary evaluations will be conducted to examine the overall soundness and fitness for competition with consideration of the cause and prognosis of any recognized unsoundness or concerns. The evaluations will be conducted by the Team Veterinarian or a Veterinarian designated by the Team Veterinarian.
 - 8.3.1 Following the final evaluation of horses prior to departure, the Team Veterinarian will confirm overall soundness and fitness for competition to the Selection Panel. In the event a definite sport entry horse is found to be unfit or unsound during evaluation, such horse may be re-evaluated within a 24-hour period. If a staging/quarantine camp is not held, the final evaluation shall be planned after final fitness work (gallop) before departure.
- 8.4 **Veterinary Records:** Athletes and/or Owners (at their own expense) shall make available, upon the request of the Team Veterinarian, the veterinary records of horse(s) being considered for selection. In addition, athletes and or owners, (at their own expense), shall be responsible for supplying any follow-up diagnostic information requested by the Team Veterinarian for horses being considered for selection. Failure to comply with any request of the Team Veterinarian may adversely affect a combination in respect to selection.
- 8.5 **Changes in Status:** Athletes must notify the Team Veterinarian of any change in their horse's health status or of any veterinary issues when health changes first become apparent.
- 8.6 **Testing:** All declared Horses are subject to testing per **Section 4** of the Selection Criteria and/or FEI Pre-Arrival-testing and/or as part of assessing the horse's well-being.



8.7 Veterinary Treatment of Horses

- 8.7.1 All Veterinary treatments / procedures conducted on all horses declared for the 2026 WC must be reported to the Team Veterinarian as of June 1, 2026.
- 8.7.2 Observations of the Team Veterinarian relating to treatment of the horse, as well as any concerns regarding the horse will be communicated to the athlete and the owner of the horse.

8.8 Veterinary Treatments - Definite Sport Entry Horses and Alternates for the 2026 WC

Following selection decisions (on or before July 3, 2026), for all selected horses (including alternates) for the 2026 WC, the Team Veterinarian must be consulted before the selected horse receives any veterinary treatment or procedure by anyone other than the Team Veterinarian. In an emergency circumstance where treatment delay could jeopardize the horse's health or welfare, the Team Veterinarian shall be notified as soon as reasonably possible.

8.8.1 Treatment Decisions - Definite Sport Entry Horses and Alternates for the 2026 WC

The Team Veterinarian, in consultation with the personal veterinarian (unless waived by the athlete), shall make all treatment decisions on a selected definite or alternate horse except in the event of an emergency circumstance where delay of treatment could jeopardize the horse's health or welfare.

8.8.2 Treatment Services - Definite Sport Entry Horses and Alternates for the 2026 WC

Only team-appointed support personnel shall provide services/treatments on a selected definite or alternate horse as of the time of departure to the 2026 WC, unless deemed appropriate by the Team Veterinarian.

8.9 Feed and supplements - Definite Sport Entry Horses and Alternates for the 2026 WC

Athletes shall keep a record for each selected horse of all products, treatments, foodstuffs and all supplements used on or given to the horse commencing 30 days prior to the competition until the conclusion of the 2026 WC.

8.10 Removal from Selection

EC reserves the right to remove an athlete/horse combination from selection, where the athlete does not comply with any of the above veterinary requests, or the horse is deemed unsound and/or unfit to travel and compete at the 2026 WC. The decision of EC is final. Should this occur, the horse will be removed. See *Appendix 1, Section 10.8*.

9 SPECIFIC SELECTION CRITERIA

9.1 **Selection Factors**

The Selection Panel will use their discretion in the selection process to attain the objectives outlined in *Appendix 1, Section 2*.

9.1.1 Performance Results

- (a) The Selection Panel will consider the performance results of the combination in FEI CCI5*-L, CCI4*-L, CCI4*-S competitions from **January 1, 2025 to June 22, 2026**.
- (b) Competition results achieved at the CCI5*-L, CCI4*-L, CCI4*-S level, prior to 2025 may be considered by the Selection Panel to demonstrate the experience of the combination.



In assessing **Section 9.1.1 (a)** and **(b)** performance results, the Selection Panel will consider, but are not limited to, the following factors:

- The demonstrated competitiveness of a declared combination throughout the Qualifying Period at the CCI4*-S, CCI4*-L and CCI5* level
- The trending performance history of the combination (i.e. is the performance improving, static or worsening)
- The potential of the combination to contribute to achieving the objectives in priority order (meaning the primary objective will be prioritized over the secondary objective), as described in *Appendix 1*, *Section 2*

9.1.2 Veterinary Evaluation Results

The Selection Panel will consider the results of any veterinary evaluations, tests or examinations, carried out with respect to the horse in considering fitness and soundness, that may affect their ability to achieve the performance objectives.

9.1.3 Performance Metrics

Performance result metrics and analysis provided by internal and external providers, including EquiRatings, may be used by the Selection Panel in comparing results for athlete/horse combinations.

10. SELECTION PROCESS/ TIMETABLE

- 10.1 **Timelines:** The timelines to be followed in the process are described in *Appendix 1, Section 5*.
- 10.2 **Entry Maximums:** The maximum number of definite sport entries permitted is dependent on team vs individual eligibility.
- 10.3 **Definite Sport Entries Team**: Canada may nominate up to 4 (four) athletes plus 4 (four) horse combinations as definite sport entries for a team. The selection of definite sport entries will be the decision of the Selection Panel and approved by the HPAG in accordance with the Selection Criteria.
- 10.4 **Definite Sport Entries Individual:** Should Canada not have enough eligible athlete/horse combinations to form a team for the 2026 WC, then definite sport entries can be selected for the individual competition up to a maximum of two athletes. The selection of definite sport entries will be the decision of the Selection Panel and will be approved by the HPAG in accordance with the Selection Criteria.

10.5 Alternate Athletes /Reserve Horses

The Selection Panel may select alternate athlete/ horse combinations. Alternates/reserves may or may not travel to the 2026 WC based on the amount of funds available.

10.6 **Continued Preparedness:** Definite sport entries and alternate, athlete/horse combinations are required to demonstrate their continued preparation, soundness and ability for the 2026 WC. This is to include at least one three-phase competition following selection at the intermediate level or above, as decided upon in collaboration with the Chef D'Equipe.



10.7 **Staging/ Quarantine Camp:** Combinations selected as definite sport entries plus alternates, may be asked to attend a pre-championships quarantine/training camp. Confirmed details will be communicated to selected athletes directly.

10.8 Substitution of Definite Sport Entry

10.8.1 Substitution Prior to Staging/Training Camp

Substitution of an athlete/ horse combination nominated as definite sport entries to the FEI with a named alternate athlete/reserve horse combination shall be made as per the 2026 WC Rules and Regulations.

A substitution may be required in the following circumstances:

- if a horse selected as a definite sport entry becomes unfit, ill or unsound such that it is, in the opinion of the Team Veterinarian, not possible or desirable to have that horse compete at 2026 WC;
- if a combination is underperforming prior to the 2026 pre-championships training/competitions to the extent that, in the opinion of the Selection Panel in consultation with the Team Veterinarian, it is reasonably likely to have a negative impact on the team's performance during the 2026 WC; or
- if an athlete selected as a definite sport entry is ill, injured, incapacitated which or is in violation of EC Elite Athlete Agreement, EC Code of Conduct, EC Policies or FEI Policies. Any substitution for medical reasons must be certified by a physician(s) who is approved by the HPAG.

The Selection Panel shall then have the authority and absolute discretion to make all such substitution decisions after reviewing all relevant evidence. Decisions may include, without limitation, and may be in consultation with the athlete(s) where appropriate, whether to (i) substitute an athlete/horse combination, (ii) reduce the number of combinations or Team entered, or (iii) nominate individual competitors in place of the Team, as circumstances require.

The final decision for substitutions prior to staging/training camp will be made by majority of the Selection Panel in consultation with Team Veterinarian with respect to any horse fitness, soundness or welfare issues and the Chef d'Equipe with respect to any changes to the composition of the Team. Any deviations from the requirements caused by changes to the composition of the Team will be made by the Selection Panel, provided that the Chef d'Equipe consents, which consent may not be unreasonably withheld or delayed. The Chef d'Equipe is charged with the responsibility of facilitating performance of the Team and shall have discretion to determine whether any change to the composition of the Team will interfere with the performance of the Team.

10.8.2 Substitution during Staging/Training Camp

A substitution may be required in the following circumstances:

- if a horse selected as a definite sport entry becomes unfit, ill or unsound such that it is, in the reasonable opinion of the Team Veterinarian, not possible or desirable to have that horse compete at 2026 WC;
- If a combination is not on a positive trajectory during the 2026 pre-championships training/quarantine camp to the extent that, in the reasonable opinion of Chef D'Equipe in consultation with the Team Veterinarian, it is reasonably likely to have a negative impact on the Team's performance during the 2026 WC;



- if an athlete selected as a definite sport entry is ill, injured, incapacitated or is in violation of EC Elite Athlete Agreement, EC Code of Conduct, EC Policies, FEI Policies or OC Policies. Any substitution for medical reasons must be certified by a physician(s) who is approved by the HPAG; or
- any athlete or horse member of a Team is unable to compete at the 2026 WC for any reason, and it is in the reasonable opinion of the Chef d'Equipe that a substitution will be reasonably likely to have a negative impact on the Team's performance during the 2026 WC, the Chef d'Equipe may withdraw the Team from performing at the 2026 WC, in her sole discretion.

The last date for substitution is the last date at which an athlete or horse selected to travel to the 2026 WC can be subject to substitution with an alternate athlete or reserve horse not previously selected to travel.

The Chef D'Equipe will consult with the Team Veterinarian and Selection Panel on any substitution or withdrawals to be made in accordance with this *Section 10.8.2*. The Chef D'Equipe shall have the authority and absolute discretion to make all such substitution or withdrawal decisions after reviewing all relevant evidence and in consultation with the athlete(s) during staging/training camp.

10.8.3 Substitution during Team Competition

The Chef d'Equipe will decide whether to substitute a combination at the 2026WC in the Team competition or whether to withdraw from such competition.

10.9 **Declaration of the order of starters at the 2026 WC:** The date for the declaration of the order of starters will be announced by the OC in the competition schedule. The declaration of the order of starters will be made by the Chef d'Equipe.

11 FORCE MAJEURE

- 11.1 **Extenuating Circumstances:** In considering the performances of athletes at events or other attendances in line with the Selection Criteria, the Selection Panel may, at their discretion, give weight to extenuating circumstances.
- 11.2 **Definition of Extenuating Circumstances:** For the purposes of *Section 11.1* above, extenuating circumstances means an inability to compete, or perform or contribute at an optimum level arising from:
 - 11.2.1 Injury or illness;
 - 11.2.2Bereavement or personal misfortune, and / or;
 - 11.2.3 any other factors considered by the Selection Panel to constitute extenuating circumstances, upon request of the declared athlete.
- 11.3 **Request for Extenuating Circumstances:** a request must be in submitted in writing to the Selection Panel c/o Eventing High Performance Chair by a declared athlete, at least 10 days prior to the definite sport entry decision deadline.
- 11.4 **Failure to Attend:** Athletes unable to compete at events or other attendances required must advise the Selection Panel c/o the Eventing High Performance Chair and provide the reasons thereof as soon as practicable after the extenuating circumstances arise.

12 COMMUNICATION



- 12.1 **Publication of criteria**: The Selection Criteria will be placed on the EC website. Inquiries about the Selection Criteria or process can be made in writing or by telephone to the Eventing High Performance Chair.
- 12.2 **Notification to HPAG:** The Selection Panel shall inform the HPAG of the selection decision.

12.3 Official Announcement

The HPAG Chair will privately and officially inform the 2026 WC athlete/horse combinations including alternates of their selection on or before **July 3, 2026**.

Non-Disclosure Policy Regarding Team Announcement

It is important that ALL athletes selected for the 2026 WC (as well as ALL owners, grooms, team personnel, and anyone else affiliated with a selected athlete, including friends, and family) respect this Non-Disclosure Policy Regarding Team Announcement until after the official announcement of the team.

Until the official team announcement, athletes and their affiliates (owners, grooms, companions, team personnel, and anyone else affiliated with a selected athlete, including friends, and family) are to refrain from confirming team selection of definite sport entries or alternative entries to any and all media, and must not make any references that confirms team selections on social media (Facebook, Twitter, Instagram, etc.).

The purpose of this non-disclosure policy is to ensure maximum impact and exposure for the announcement of the athletes who will represent Canada at the 2026 WC.

Violation of this non-disclosure policy may result in sanctions, up to and including exclusion from selection.

13. FUNDING DISCLAIMER: EC, including HPAG, is dedicated to providing the necessary funds for a Canadian Eventing Team and/or individuals to compete at the 2026 WC to the extent it is reasonably possible. Any costs not covered by EC may be required to be covered by the members of the team on an equitable basis.

EVENTING SELECTION PANEL MEMBER JOB DESCRIPTION

COMPOSITION: The Eventing Selection Panel (Selection Panel) shall be comprised of three members (each a Selector). **ACCOUNTABILITY:** The Selection Panel reports its decision to the Eventing High Performance Advisory Group. **TERM OF OFFICE:** A term of office for a Selector shall be an Olympic Cycle. (4 years, to be evaluated by the HPAG after the next Olympic Games).

ROLE AND RESPONSIBILITIES

The Selection Panel is responsible for identifying and selecting the athlete/horse combinations deemed most capable of team completion-and an internationally competitive result, for senior major games and championships, including the Olympic Games, World Championships, Pan American Games and Nations Cups, through a fair, transparent and documented selection process.

The Selection Panel is also responsible for identifying and selecting the athlete/horse combinations for Nations Cup teams based on the overall objectives laid out by the HPAG.

The duties of the Selection Panel will include, but are not limited to:

- 1. Establishing objectives of the Criteria.
- 2. Selecting the combinations (and alternate combinations) to be nominated to, or selected by, EC in accordance with the published Criteria.
- 3. Ruling on contentious issues in the nomination or selection process or in the application process.
- 4. Ensuring all performance results under review are accurate.
- 5. Observing at designated competitions.
- 6. Selecting the alternates subject to the Selection Criteria and the FEI regulations and policies where applicable.
- 7. Reviewing reports related to the horse evaluations/examinations.

QUALIFICATIONS AND EDUCATIONAL REQUIREMENTS:

1. Competed at the Advanced Level or have obtained Level 3 or above FEI Eventing Official status with a minimum of 3 years' experience involved at Eventing High Performance levels.

Selection Panel members may not have been previously removed from an EC committee for violating EC Policies or Rules. In addition to following EC's rules, regulations, policies and procedures. Selectors must hold a current EC Sport license and complete, prior to the first committee meeting, a Non-disclosure Agreement (NDA).

PREFERRED SKILLS:

- 1. Understanding of the particular competition being selected for (Olympics, World Championships, Pan American Games, Nations Cups) including the level of competition, terrain, competition site and other potential challenges.
- 2. Ability to understanding results at various global events in relation to other events e.g. appreciating that all CCI4* and CCI5*events are not the same.
- 3. Understanding of how the sport has evolved over the last decade.
- 4. Ability to communicate effectively with athletes without bias.
- 5. Ability to travel to targeted major competitions identified in the annual selection plan (within their respective global region).
- 6. Knowledge of the major (FEI) competition venues around the world.
- 7. Knowledge and awareness of other nation's team programs with a clear understanding of the current performance standard of the world's top nations.
- 8. Understanding of key performance evaluation metrics available and how to measure. (i.e. EquiRatings).
- 9. Horse capability knowledge/ understanding of horse/ athlete strengths relative to type of competition or track. i.e. horses for courses.

INABILITY TO COMPLETE A TERM:

If a Selection Panel member vacates their position during their term, the CEO of Equestrian Canada on the recommendation of the HPAG may appoint a qualified individual to complete such term.



The HPAG and/or the CEO of Equestrian Canada may remove a Selection Panel member in the following circumstances:

- 1. A conflict of interest issue arises that cannot be resolved; and/or,
- 2. A member is unable to fulfill their responsibilities; and/or
- 3. A member has been found to be in violation of EC rules, regulations and/or policy; and/or
- 4. A member uses the information gained through their association with the Committee/HPAG to cause public harm, including without limitation, any defamation or other damage to reputation, to the Committee, HPAG, EC staff, participants or the organization.



DEFINED TERMS

Where used in this document, unless otherwise defined, acronyms and capitalized words have the following meanings:

- "2026 WC" means the 2026 FEI World Championships, Aachen, Germany.
- "CADP" means the Canadian Anti-Doping Program responsible for drug testing of athletes in Canada.
- "Canadian Eventing Team" means the team of athlete /horse combinations nominated to the FEI to represent Canada at the 2026 WC.
- "CCI" means Concours Complet International (International Eventing Competition Event). The CCI has different competition formats and held different levels, with the higher numbers meaning a higher level; the star ratings for events:
- **CCI L:** Concours Complet International long the FEI sanctioned international long format eventing competition (formerly known as CCI).
- CCI S: Concours Complet International short the FEI sanctioned international short format eventing competition (formerly known as CIC).
- "CEO" means the EC Chief Executive Officer (Meg Krueger).
- "CET" means the Canadian Equestrian Team, as determined by Equestrian Canada.
- "Chef d'Equipe" means the EC Eventing Chef d'Equipe / Technical Adviser (Rebecca Howard).
- "DHP" means the EC Director High Performance (James Hood).
- "Discipline Manager" or "DM" means the EC Chair of Eventing, High Performance.
- "EC" means Equine Canada operating as Equestrian Canada.
- "EC Games Portal" means the internet registration portal for EC used for Major Games.
- **"Eventing High Performance Chair"** means the Chair of Eventing, High Performance (Dr. Emily Gilbert).
- "FEI" means the International Federation for Equestrian Sports the Fédération Equestre Internationale.
- "HPAG" means the EC High Performance Advisory Group for Eventing.
- "High Performance Eventing Team Personnel" means the Director of High Performance (James Hood), Chair of High Performance (Dr. Emily Gilbert), Chef D'Equipe and Technical Advisor (Rebecca Howard) and Veterinarians (Dr. Alan Manning and Dr. Emily Jantzi).
- "MER" means the Minimum Eligibility Requirement established by IF for qualification for the 2026 WC.
- "MER Qualification Period" means the period determined by FEI and EC -Eventing (1st January 2025 until June 22nd, 2026 inclusive) within which MER must be achieved as a combination.
- "OC" means the organizing committee for the 2026 WC.
- "Qualifying Period" means January 1, 2025 to June 22, 2026.
- "SDRCC" means the Sport Dispute Resolution Centre of Canada, an independent adjudicative body for sport in Canada.
