



2026 FEI WORLD CHAMPIONSHIPS EQUESTRIAN CANADA SELECTION CRITERIA & PROCEDURES – **PARA DRESSAGE**

1. INTRODUCTION

- 1.1 The purpose of this document is to set out the selection criteria and procedures (“**Selection Criteria**”) that Equestrian Canada (“**EC**”) will use to select athlete/horse combinations to compete at the 2026 FEI World Championships Aachen (“**2026 WC**”) for Para Dressage scheduled for August 19th – 23, 2026.
- 1.2 Discipline-specific Selection Criteria are outlined in *Appendix 1*. Questions specific to the Selection Criteria should be directed to the Discipline Manager (“**DM**”) Christine Peters at: cpeters@equestrian.ca.
- 1.3 Athlete/horse combinations must meet the expectations as outlined in these Selection Criteria in order to be considered for selection.
- 1.4 Athletes and owners who choose to participate in the selection process acknowledge by their participation and declaration that meeting the requirements outlined in these Selection Criteria does not guarantee that an athlete/horse combination will be selected.
- 1.5 It is important for the integrity of the selection process that athletes, grooms, owners, athlete companions, carer, team support personnel and associated parties involved in the selection process, practice at all times a high degree of confidentiality relating to information which may have a bearing on selection, and/or any selection decisions. All confidential information, conversations, and discussions will be identified as such. Any person who breaks this confidentiality may be removed from the selection process.
- 1.6 If there is a difference in interpretation between this document’s French and English versions, then the English version shall prevail.
- 1.7 Any intentional misrepresentation of information submitted for selection consideration may in the sole discretion of EC, eliminate the athlete/horse combination from both the qualifying process and from consideration for selection.

2. ELIGIBILITY

- 2.1 To be eligible for selection consideration for the 2026 WC, the following minimum eligibility requirements listed in this section must be met:
- 2.2 **Athlete**
 - Be a Canadian citizen at the time of declaration and until the conclusion of the 2026 WC
 - Have a Canadian passport that is valid until at least **November 23, 2026**
 - Meet the European Union’s travel requirements that are in place at the time of the 2026 WC including the [European Travel Information and Authorization System \(“ETIAS”\)](#) and meet the [European Union’s Entry/Exit System \(“EES”\)](#)
 - Be eligible to travel to any required quarantine/training camp and the 2026 WC
 - Be in compliance with all relevant International Federation (“**FEI**”) requirements for eligibility
 - Be a member in good standing (Platinum Sport Licence Holder) with EC
 - Hold a current FEI Registration and be in good standing with the FEI



- Sign and submit the EC Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - [Safe Sport policies](#)
 - [The Universal Code of Conduct to Prevent and Address Maltreatment in Sport \(“UCCMS”\)](#)
 - [Canadian Safe Sport Program](#), as applicable
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines, including for the [Canadian Anti-Doping Program \(“CADP”\)](#)
- Meet minimum athlete age requirements as per the 2026 FEI Regulations:
 - Para Dressage: 16 years of age, born on or before December 31st, 2010

2.3 Horse

- Meet minimum horse age requirements as per the 2026 FEI Regulations for Equestrian Events:
 - Para Dressage: 6 years of age in 2026, born on or before December 31st, 2020
- Possess a valid FEI Horse Registration document (passport) and be in good standing

2.4 Groom

- Be a minimum of 18 years of age at the time of the 2026 WC
- Have a passport that is valid until at least **November 23, 2026**
- Meet the European Union’s travel requirements that are in place at the time of the 2026 WC including the [European Travel Information and Authorization System \(“ETIAS”\)](#) and meet the [European Union’s Entry/Exit System \(“EES”\)](#)
- Be eligible to travel to any required quarantine/training camp and the 2026 WC
- Have experience competing or grooming at international equestrian competitions
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines, including for the [CADP](#)
- Sign and submit the EC Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - [Safe Sport policies](#)
 - [The Universal Code of Conduct to Prevent and Address Maltreatment in Sport \(“UCCMS”\)](#)
 - [Canadian Safe Sport Program](#), as applicable

2.5 Owner

- Have a passport that is valid until at least **November 23, 2026**
- Meet the European Union’s travel requirements that are in place at the time of the 2026 WC including the [European Travel Information and Authorization System \(“ETIAS”\)](#) and meet the [European Union’s Entry/Exit System \(“EES”\)](#)
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines
- At minimum one Owner must be listed as an owner in the FEI horse passport unless the horse is owned by a syndicate
- Must sign and submit the EC Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - [Safe Sport policies](#)
 - [The Universal Code of Conduct to Prevent and Address Maltreatment in Sport \(“UCCMS”\)](#)
 - [Canadian Safe Sport Program](#), as applicable

2.6 Carer

- Be a minimum of 18 years of age at the time of the 2026 WC
- Have a passport that is valid until at least **November 23, 2026**
- Meet the European Union’s travel requirements that are in place at the time of the 2026 WC including the [European Travel Information and Authorization System \(“ETIAS”\)](#) and meet the [European Union’s Entry/Exit System \(“EES”\)](#)



- Have experience as a carer at international equestrian competitions
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines
- Must sign and submit the EC Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - [Safe Sport policies](#)
 - [The Universal Code of Conduct to Prevent and Address Maltreatment in Sport \(“UCCMS”\)](#)
 - [Canadian Safe Sport Program](#), as applicable

2.7 Support Team Members

- Have a passport that is valid until at least **November 23, 2026**
- Meet the European Union’s travel requirements that are in place at the time of the 2026 WC including the [European Travel Information and Authorization System \(“ETIAS”\)](#) and meet the [European Union’s Entry/Exit System \(“EES”\)](#)
- Be eligible to travel to any required quarantine/training camp and the 2026 WC
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines
- Must sign and submit the EC Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - [Safe Sport policies](#)
 - [The Universal Code of Conduct to Prevent and Address Maltreatment in Sport \(“UCCMS”\)](#)
 - [Canadian Safe Sport Program](#), as applicable

2.8 Athlete Companion (should accreditation be available)

- Have a passport that is valid until at least **November 23, 2026**
- Meet the European Union’s travel requirements that are in place at the time of the 2026 WC including the [European Travel Information and Authorization System \(“ETIAS”\)](#) and meet the [European Union’s Entry/Exit System \(“EES”\)](#)
- Provide all the information and documents necessary for the declaration, entry, and accreditation processes by the required deadlines
- Must sign and submit the EC Athlete/Participant Agreement and adhere to all EC policies related to team preparation, training, and competition. This includes compliance with:
 - [Safe Sport policies](#)
 - [The Universal Code of Conduct to Prevent and Address Maltreatment in Sport \(“UCCMS”\)](#)
 - [Canadian Safe Sport Program](#), as applicable

3 DECLARATION AND ACCREDITATION PROCEDURES

Declaration

- 3.1 **Deadline Date:** Athletes must submit a declaration for the 2026 WC to EC through the EC Games Portal on or before **12 midnight ET, January 7, 2026**. Failure to submit the required information and documents by this deadline will make the declaration incomplete and invalid. *No late declarations will be accepted, except for already declared athletes in accordance with Section 3.8.*
- 3.2 **Purpose:** The declaration date allows sufficient time for the Accreditation Process to be completed for athletes, grooms, owners, and support team personnel.
- 3.3 **Process:** The declaration MUST be made through the EC Games Portal at
 - New users: <https://licence.equestrian.ca/gamesdb/register?user=new>
 - Existing users: <https://licence.equestrian.ca/gamesdb/login.aspx>
- 3.4 **Fees:** Declaration fees, if any, are outlined in *Appendix 1*.



At the time of declaration, the athlete MUST provide:

- 3.5 **Horses:** The name, FEI passport number, and FEI passport expiry date for each declared horse, *Please refer to Section 2.3 for horse eligibility.*
- 3.6 **Grooms:** The name, *unique e-mail address*, and phone number for a minimum of two (2) up to a maximum of four (4) declared grooms in priority order. Athletes are responsible for ensuring that their groom is eligible (*please refer to Section 2.4 for groom eligibility*), kept informed, and available for the time commitments in the proposed schedule for 2026 WC (an expected four-week commitment which includes any potential staging camp period). Should a groom not carry out their assigned duties and obligations or exhibit inappropriate behavior detrimental to the team, then EC has the authority to remove such groom from the team. Please refer to the discipline-specific Selection Criteria in *Appendix 1* for additional groom information, as applicable.
- 3.7 **Owners:** The name, *unique e-mail address*, and phone number for up to two (2) declared owners per horse, in priority order for accreditation purposes; at least one owner must be listed in the FEI passport. In the case of syndicate ownership groups, declared athlete/horse owners do not need to be individually listed in the FEI passport, but must be individually declared in priority for accreditation purposes. *Please refer to Section 2.5 for owner eligibility.*

At the time of declaration the athlete may provide:

- 3.7 **Athlete Companions:** The name, *unique e-mail address*, and phone number for up to two (2) declared athlete companions, in priority order for accreditation purposes. *Please refer to Section 2.8 for athlete companion eligibility.*

Carers: The name, *unique e-mail address*, and phone number for up to two (2) declared carers, in priority order for accreditation purposes. *Please refer to Section 2.6 for carer eligibility.* EC reserves the right to deem a carer ineligible for an international team competition. Should a carer not carry out their assigned duties and obligations or exhibit inappropriate behavior detrimental to the team, then EC has the authority to remove such carer from the team. Refer to the discipline-specific Selection Criteria in *Appendix 1* for additional carer information, as applicable.

- 3.8 **Declaration Date Exception:** Except as set out in this Section 3.8, athletes may not submit a declaration after the **12 midnight ET, January 7, 2026**, deadline.

3.8.1 In the case of a horse being made available **to an already declared athlete** after the declaration deadline to form a “New athlete/horse combination”, EC may, in its sole discretion, accept this athlete/horse combination as a declared candidate for the 2026 WC.

3.8.2 Additional athlete/horse combinations must be submitted in writing to EC at the earliest date possible, and no later than **March 30, 2026**.

Note 1: Horse owner accreditation may not be possible for new horses declared after the **12 midnight ET, January 7 2026** deadline.

Note 2: “New athlete/horse combination(s)” are defined as either a:

- new horse purchase, or
- horse transfer to an already declared athlete

- 3.9 **Withdrawal:** Declared athletes who subsequently choose to withdraw from the selection process (either themselves or their horse) prior to the naming of the team and alternates must advise the EC DM of their decision in writing.



Accreditation

- 3.10 **Process:** The accreditation process for the 2026 WC will be coordinated through EC. To help facilitate this process, the athletes' declaration in the EC Games Portal must include the personal **unique e-mail addresses** and phone numbers for all potential grooms, owners, athlete companions and carers. Any subsequent changes to accreditation details, i.e. new owners, grooms etc., must be reported to the EC DM immediately in writing. **Athletes, grooms, owners, athlete companions, carers, and team personnel are not permitted to apply directly to the Aachen Organizing Committee ("OC") for accreditation.**
- 3.11 **Allocation:** EC has the exclusive authority to select and allocate accreditations for the grooms, owners, athlete companions, carers and team personnel who comprise the Canadian Equestrian Team ("CET") to represent Canada at the 2026 WC. Accreditations for 2026 WC are limited and are allocated based on the needs of the entire team and on what EC decides will lead to the best team performance at the 2026 WC.
- 3.12 **Information Deadline:** Athletes, grooms, owners, athlete companions, carers, and team support personnel are to provide all necessary accreditation information, including photos and passport details and personal information, in the EC Games Portal by the Declaration deadlines outlined in Sections 3.1 and 3.8 above.
- 3.13 **Declared list:** It is very important that information is provided and entered in the EC Games Portal for EVERY possible individual who may attend the 2026 WC in an accredited role (Athlete, Owner, Groom, Athlete Companion, Carer, Team Personnel, etc.) prior to the declaration deadline referenced in Section 3.12. Participation in this process does not guarantee accreditation nor selection.

Release of Liability Waiver

- 3.14 All declared athletes, grooms, owners, athlete companions, carers and team personnel must complete and return the release of liability waivers to the DM within 7 days following notification of their selection in July 2026. The waiver and release forms can be found in the following appendices:
- **Appendix 2:** Athlete Release of Liability, Waiver of Claims, Assumption of Risk, and Indemnity Agreement
 - **Appendix 3:** Groom / Athlete Companion/Carers/Team Personnel Release of Liability, Waiver of Claims, Assumption of Risk, and Indemnity Agreement
 - **Appendix 4:** Owner Release of Liability, Waiver of Claims, Assumption of Risk, and Indemnity Agreement
 - **Appendix 5:** Release of Veterinary Medical Records

4 ANTI-DOPING HUMAN AND EQUINE

Athlete

- 4.1 **Eligibility:** The athlete must not be under suspension or any other sanction by any recognized body for any doping or doping-related offense.
- 4.2 **Testing:** Declared athletes may be subject to announced and unannounced drug testing in accordance with the **CADP**. Testing includes both in-competition and out-of-competition testing. All athletes who declare for the selection process must provide accurate and up-to-date contact information through the EC Sport Licence portal.
- 4.3 **Deemed Violation:** Athletes who do not provide up-to-date contact information or respond to EC communications, will be considered in violation of these policies. Violations will be considered in context by the Discipline's High Performance Advisory Group ("**HPAG**") and may result in the disqualification of the athlete from the selection process.

Horse

- 4.4 **Testing:** All declared horses shall be subject to drug testing according to FEI drug and medication rules. Blood, and/or urine, or any other sampling method as instituted by the FEI may be drawn at any time throughout the



qualification, selection and quarantine/training camp periods. Samples may be tested for the presence for all prohibited and/or controlled substances by the FEI.

- 4.5 **Prohibited Substances:** In the event a prohibited substance is detected, the amount of this substance will be quantified where possible and reported to the EC DM. Any horse whose sample contains a prohibited substance or a restricted substance in a concentration greater than the allowable FEI limits may be eliminated from the selection process. Positive test results from samples collected during FEI competition will result in disqualification of that athlete/horse combination in all classes at that competition.

5 APPEALS

- 5.1 **Grounds:** Athletes participating in the selection process for the 2026 WC have the right to appeal against a selection decision but only on the grounds that the HPAG has failed to comply with the correct procedures outlined in the Selection Criteria or has made a patently unreasonable decision based on the Selection Criteria. An appeal must be made in writing to the Independent Third Party Complaint Manager within 72 hours of the relevant athlete being informed of the decision. Appeals must be accompanied by an administration fee of \$1,000.00 (CAD) as per the published EC Schedule of Fees, unless waived by EC, in its sole discretion, as set out in s. 74 of the Discipline, Complaints and Appeal Policy approved April 14, 2025. The EC Discipline, Complaints and Appeal Policy can be found [HERE](#).
- 5.2 **Process:** In recognition of the short timelines required for the selection decision process, any appeals to decisions made under the Selection Criteria will proceed under the Sport Dispute Resolution Centre of Canada (“SDRCC”) appeal process. The administration fee referred to in Section 5.1 will be applied to the fee required for the appeal to SDRCC. All appeals must be resolved prior to final entry deadline for the 2026 WC as determined by the FEI criteria.

6 AMENDMENTS TO THE SELECTION CRITERIA

- 6.1 The Selection Criteria are based on applicable FEI regulations, conditions and restrictions as currently known and understood, and on the latest information available to EC for [PARA DRESSAGE](#) by the FEI.
- 6.2 Any changes in the Selection Criteria necessitated by a change in FEI regulations will be distributed via email to the declared athletes as soon as reasonably possible. Should such a circumstance occur, EC will review and may amend Selection Criteria to comply with the new regulations or conditions. Any amendments to this document will be communicated directly to all declared athletes via email. Communication will be sent to the email address provided in the EC Games Portal.
- 6.3 Further, situations may arise that do not allow this Selection Criteria to be modified or applied as written due to time constraints or other exceptional and unforeseen circumstances. In such situations, any decision, including selection decisions, will be made by the individual(s) with decision-making authority, as stated in this Selection Criteria, in consultation with the Director, High Performance, Team Physician, Team Veterinarian, HPAG or other individuals or committee(s) (as applicable), and in accordance with the stated performance objectives and selection philosophy and approach as stated herein. Should it be necessary to make any decision in this manner, EC will communicate with all declared athletes as soon as possible.



Appendix 1

PARA DRESSAGE SELECTION CRITERIA

1. TEAM/INDIVIDUAL COMPOSITION

- 1.1 Team Selection:** EC plans to select a team (of three or four athlete/horse combinations) to compete in the para dressage competition at the 2026 WC. At least one (1) team member shall be an eligible athlete in either sport class Grade I, II or III. To form a team Canada can enter a maximum of two (2) eligible athletes per sport class.
- 1.2 Individual Selection:** Should Canada not obtain a team qualification or should Canada not have enough eligible athlete/horse combinations to form a team for the 2026 WC, then entry in the individual event will be subject to the decision and approval of the HPAG in consultation with the EC Director, High Performance (“DHP”) and the Discipline Manager (“DM”), in accordance with the FEI regulations and these qualification and selection procedures.
- 1.3 The performance objective for the Canadian Para Dressage team at the 2026 WC is team top 8.

2. QUALIFICATION

- 2.1 The Qualification Period (“QP”) for the 2026 WC shall run from **November 1, 2025 to July 5, 2026**, inclusive.
- 2.2 Qualification of athlete/horse combinations for the 2026 WC will consist of a four-stage process:
- 2.2.1 Stage One – EC Declaration
 - 2.2.2 Stage Two – FEI Certificate of Capability
 - 2.2.3 Stage Three – EC Qualification Score Requirements
 - 2.2.4 Stage Four – EC Fitness Inspections

2.2.1 Stage One – EC Declaration

As a condition of declaration for the 2026 WC, an athlete must fulfil the following eligibility conditions:

- 2.2.1.1 Must have submitted the 2026 WC declaration and non-refundable declaration fee of \$200.00 CAD per athlete through the EC Games Portal on or before the declaration deadline **12 midnight ET on Friday, January 7, 2026**. Exception see *Section 3.8* of the Selection Criteria.

2.2.2 Stage Two – FEI Minimum Eligibility Requirement (MER) / Certificate of Capability PARA DRESSAGE

Qualification Period (“QP”):

- Start: 1 January 2025
- End: Nominated entries date

Minimum Qualification Criteria: (art 8404 Para Dressage Rules)

Qualifying Events:

Any CPEDI 3* or above event during the QP (2025 Continental Championships included).

Qualification Score:



In order to qualify for participation, athletes and horses must have attained (as a combination) one result of at least 64 %, attributed by the Ground Jury, in a Para Grand Prix A or Para Grand Prix B test in their respective Grade.

2.2.3 Stage Three – EC Qualification Score Requirements

- 2.2.3.1 Technical qualification scores (Para Grand Prix A or Grand Prix B) must be achieved at CPEDI3* or higher competitions within the QP see ***Appendix 1***, Section 2.1. Technical Scores achieved at National (Gold) competitions will not be considered.
- 2.2.3.2 Freestyle qualification scores (Para Grand Prix Freestyle) must be achieved at CPEDI3* or higher competitions within the QP see ***Appendix 1***, Section 2.1. Freestyle Scores achieved at National (Gold) competitions will not be considered.
- 2.2.3.3 Scores must be from the current FEI Para Dressage tests.
- 2.2.3.4 All qualification scores must be achieved from a panel of at least three FEI judges. The full panel score is required. Scores from individual judges on the panel will not be considered.
- 2.2.3.5 Athlete/horse combinations must compete in a minimum of four (4) Technical tests (Para Grand Prix A / Para Grand Prix B) and a minimum of two (2) Freestyle tests (Para Grand Prix Freestyle) during the QP.
- 2.2.3.6 A minimum of one (1) Para Grand Prix A, Para Grand Prix B and one (1) Para Grand Prix Freestyle score must be achieved within the QP after **May 1, 2026**.
- 2.2.3.7 The four (4) highest technical scores achieved by each athlete/horse combination will be considered for qualification. The average of the four (4) technical scores must be 69%, or higher.
- 2.2.3.8 The highest freestyle score achieved by each athlete / horse combination will be considered to break a tie should there still be a tie the highest technical score achieved in the most recent freestyle will break the tie.
- 2.2.3.9 All 2026 CPEDI3* scores achieved by each declared athlete/horse combination will be reviewed by the HPAG the week of **July 6, 2026**.
- 2.2.3.10 Scores may be achieved from the following designated qualifying Tests.

Grade I

- FEI PE Grade I Grand Prix A Test
- FEI PE Grade I Grand Prix B Test
- FEI PE Grade I Grand Prix Freestyle to Music

Grade II

- FEI PE Grade II Grand Prix A Test
- FEI PE Grade II Grand Prix B Test
- FEI PE Grade II Grand Prix Freestyle to Music

Grade III

- FEI PE Grade III Grand Prix A Test
- FEI PE Grade III Grand Prix B Test
- FEI PE Grade III Grand Prix Freestyle to Music

Grade IV



- FEI PE Grade IV Grand Prix A Test
- FEI PE Grade IV Grand Prix B Test
- FEI PE Grade IV Grand Prix Freestyle to Music

Grade V

- FEI PE Grade V Grand Prix A Test
- FEI PE Grade V Grand Prix B Test
- FEI PE Grade V Grand Prix Freestyle to Music

2.2.3.11 Grade Changes

- i. Athletes who are reclassified by the FEI to a lower grade from their original classification grade (i.e.: Grade III to Grade II) 6 months before the 2026 WC must qualify pursuant to the Qualification Criteria outlined in *Appendix 1*, Section 2. Reclassified athletes must qualify for the 2026 WC at their new classification grade. In this case the athlete's declaration will roll over to the new classification grade.
- ii. Note: FEI rules only permit reclassified athletes to compete at their original classified grade for another 2 months after the reclassification.
- iii. EC reserves the right to require an athlete with a review status to be re-assessed to confirm their classification grade as a condition of eligibility for selection. Timelines for review status are athlete specific and can be found on the FEI Master List.

2.2.4 Stage Four – EC Fitness Inspections

2.2.4.1 Physician Assessment

- i. It is of paramount importance that each athlete is fit-to-compete and that the welfare of the athlete is protected. EC and the HPAG wish to ensure that no unfit athlete travels to and competes at the 2026 WC. As part of the selection process the advice from the Team Physician (if appointed or otherwise treating physician), if so required, will be taken into consideration to ensure athletes considered for selection are healthy and fit-to-compete

2.2.4.2 Veterinary Assessment

- i. **Purpose:** It is of paramount importance that the horse be serviceable and that the welfare of the horse be always protected. EC and the HPAG wish to ensure that no unfit or unsound horse travels to or competes at the 2026WC. All declared horses shall be subject to drug testing according to FEI drug and medication rules. Blood and/or urine samples may be drawn at any time throughout the qualification, selection and quarantine / staging camp periods. Samples may be tested for the presence of substances identified by the FEI as both forbidden and/or controlled. Positive test results from samples collected during FEI competition will result in a zero (0) score for that athlete/horse combination in all classes at that competition. Athletes and owners are responsible and accountable for all positive testing results.
- ii. **Advice:** As part of the selection process, the advice from the Team Veterinarian will be taken into consideration during the selection process to ensure that all horses considered for selection are healthy and fit-to-compete.
- iii. **Assessment:** An assessment for soundness and serviceability for competition will be conducted on all selected horses, including alternates, by the Team Veterinarian prior to the departure of the horses for the 2026 WC. Assessments will examine the overall



soundness and suitability for competition with consideration of the cause and prognosis of any recognized unsoundness. In the event a selected horse is found to be unfit or unsound during assessment, they may be re-presented within a 24-hr period for re-assessment. Should the horse be unable to proceed to the 2026 WC, the HPAG will remove the horse based on *Appendix 1*, Section 4 SUBSTITUTIONS below.

- iv. **Communication:** Throughout the selection process, observations and concerns identified by the Team Veterinarian will be communicated orally or in writing to the athlete of the horse in question. The onus will be upon the athlete to take any necessary action in order to follow the recommendations of the Team Veterinarian.
- v. **Medical History:** Open and ongoing communication between the regular veterinarian, all treating veterinarians, and the Team Veterinarian is required throughout the qualification period. To ensure proper oversight and preparation of horses for the 2026 World Championships, athletes and owners may be required, upon request, to provide up to six (6) months of complete medical history. This must include all treatments, medications, and supplements administered to declared horses, and must be supplied directly by the regular and/or treating veterinarian(s)

3. SELECTION PROCESS

3.1 High Performance Advisory Group (HPAG)

The HPAG is the selection panel for the 2026 WC. The member of the HPAG can be found at: <https://equestrian.ca/sport/para-dressage/>

No voting or non-voting member of the HPAG shall participate in any discussions or decisions regarding the selection of any athletes with whom they have a perceived or real conflict of interest. Any member of the HPAG who considers that they are in a position of perceived or real conflict of interest must declare such a conflict before any discussions are held or decisions are made and must remove themselves from all discussions regarding selection until the matter giving rise to the perceived or real conflict of interest has been resolved by the HPAG.

3.2 HPAG Specific Responsibilities

- Oversee the selection of Canadian athlete/horse combinations to represent Canada internationally.
- Support management in dealing with appeals and disciplinary actions related to selection.
- Review athlete development through objective assessment tools in collaboration with the Performance Analyst, for selection purposes.
- Liaise with Team Physician and Team Veterinarian as required.

3.3 Selection Procedures

- 3.3.1 Following the completion of the QP (see *Appendix 1*, Section 2.1), the HPAG will review all scores achieved by each declared athlete / horse combination
- 3.3.2 Consideration for selection will be determined based on the FEI rules for team composition outlined in *Appendix 1*, Section 1.1 and on the final ranking average of all scores achieved as outlined in *Appendix 1*, Section 2.2.3. EC Fitness Inspection results (see *Appendix 1*, Section 2.2.4) will also be considered during the selection process.



3.3.3 Extraordinary Unforeseen Circumstances

The HPAG may consider athlete/horse combinations that did not achieve the **Section 2.2.3** Stage Three EC Qualification Score Requirements for selection, but only under extraordinary, unforeseen circumstances. Extraordinary, unforeseen circumstances may include, without limitation, situations of temporary illness or injury to either the athlete or the horse that are outside the reasonable control of the athlete, extreme weather causing cancellation of a qualification event, or unusual and unforeseen events occurring at a qualification event or preventing access to one or more qualification events or preventing one or more qualification events from taking place, etc.

In the event of such extraordinary, unforeseen circumstances the HPAG will determine if the circumstances justify competition or selection should take place in an alternative manner. In such circumstances, the HPAG shall communicate the alternative selection process to all impacted individuals as soon as possible.

3.3.4 Athlete/horse combinations will be formally selected on or before July 10, 2026.

3.3.5 Following selection, selected athlete/horse combinations plus named alternates, will be required to attend the 2026 WC quarantine staging camp. Confirmed details for the 2026 WC quarantine staging camp will be communicated to all declared athletes directly. The expected timelines for the quarantine staging camp will be between **August 1 – August 17, 2026**.

4 SUBSTITUTIONS

4.1 Should the need arise prior to the start of the 2026 WC, substitutions shall be made as per FEI requirements for substitution and in accordance with this document. In the event of a conflict between these Selection Criteria and the FEI and or OC rules, the latter two shall prevail.

4.1.1 Substitutions After Selection but Before the 2026 WC Quarantine / Staging Camp

Should the need for a substitution arise prior to the 2026 WC quarantine / staging camp the following provisions shall apply: (i) if a selected horse becomes unfit, ill or unsound such that it is, in the reasonable opinion of the Team Veterinarian, not possible or desirable to have that horse compete at the 2026 WC; or (ii) if a selected athlete is ill, injured, incapacitated or engages in misconduct, including violation of the EC Athlete Agreement, EC Code of Conduct and/or EC Policies, FEI Policies, Anti-Doping Policies or OC Policies, so that it is not possible or desirable for the athlete to represent Canada at 2026 WC, then the HPAG shall have the authority to make all such substitution decisions after reviewing all relevant evidence in connection with any illness, injury, misconduct or unsoundness issues.

4.1.2 Substitutions During the 2026 WC Quarantine / Staging Camp

Should the need for a substitution arise during the 2026 WC quarantine / staging camp the following provisions shall apply: (i) if a selected horse becomes unfit, ill or unsound such that it is, in the reasonable opinion of the Team Veterinarian, not possible or desirable to have that horse compete at 2026 WC; or (ii) should a situation arise where an athlete/horse combination is underperforming during the 2026 WC quarantine / staging camp to the extent that, in the reasonable opinion of the HPAG, it is reasonably likely to have a negative impact on the team's performance during the 2026 WC; or (iii) if a selected athlete is ill, injured, incapacitated or engages in misconduct, including violation of the EC Athlete Agreement, EC Code of Conduct and/or EC Policies, FEI Policies, Anti-Doping Policies or OC Policies, so that it is not possible or desirable for the athlete to represent Canada at 2026 WC, then the HPAG shall have the authority and absolute discretion to make all such substitution decisions after reviewing all relevant evidence.

4.1.3 Substitutions After Departure for the 2026 WC but Prior to the Horse Inspection

Should the need for a substitution arise after departure for the 2026 WC, but prior to the horse inspection the following provisions shall apply: (i) if a selected horse becomes unfit, ill or unsound



such that it is, in the reasonable opinion of the Team Veterinarian, not possible or desirable to have that horse compete at the 2026 WC; or (ii) if a selected athlete is ill, injured, incapacitated or engages in misconduct, including violation of the EC Athlete Agreement, EC Code of Conduct and/or EC Policies, FEI Policies, Anti-Doping Policies or OC Policies, so that it is not possible or desirable for the athlete to represent Canada at 2026 WC, then the DHP, DM and Chef d'Equipe shall have the authority and absolute discretion to make a substitution decision as per the FEI rules and the OC rules. The DHP, DM and Chef d'Equipe must all be in agreement and in support of the substitution in order for a substitution to be made.

5 Official Announcement

- 5.1 The HPAG will privately inform the 2026 WC athlete/horse combinations including alternates of their selection on or before **July 10, 2026.**

Non-Disclosure Policy Regarding Team Announcement

It is important that ALL athletes selected for the 2026 WC (as well as ALL owners, grooms, athlete companions, carers, team personnel, and anyone else affiliated with a selected athlete, including friends, and family) respect this Non-Disclosure Policy Regarding Team Announcement until after the official announcement of the team by EC.

Until the official EC team announcement, athletes and their affiliates (owners, grooms, athlete companions, carers, team personnel, and anyone else affiliated with a selected athlete, including friends, and family) are to refrain from confirming team selections to any and all media, and should not make any references that confirms team selections on social media (Facebook, Twitter, Instagram, Snapchat etc.).

The purpose of this non-disclosure policy is to ensure maximum impact and exposure for the announcement of the athletes who will represent Canada at the 2026 WC.

Violation of this non-disclosure policy may impact your selection.

- 5.2 EC will officially announce the selected athlete/horse combinations. The date of the official announcement will be provided to the athletes when they are notified in writing of their selection. There will be no mention of the selections to the media or public until the official announcement has been made by EC.

“**CPEDI**” means Concours de Para Dressage International (International Para Dressage Event) and has different levels, with the higher numbers meaning a higher level; the star ratings for events also relate to a number of other factors, such as the level of the judges present, the participation requirements and the prizemoney on offer;

“**CET**” means the Canadian Equestrian Team, as determined by Equestrian Canada;

“**Discipline Manager**” or “**DM**” means the EC Dressage Discipline Manager, Christine Peters;

“**EC**” means Equine Canada operating as Equestrian Canada;

“**EC Games Portal**” means the internet registration portal for EC used for Major Games;

“**FEI**” means the Fédération Equestre Internationale (International Equestrian Federation);

“**HPAG**” means the EC High Performance Advisory Group;

“**DHP**” means the EC Director, High Performance, James Hood;

“**MER**” means the Minimum Eligibility Requirements established by FEI for qualification for the 2026 WC;

“**MER Period**” means the period determined by the FEI within which MER must be achieved as a combination;

“**OC**” means the Organizing Committee for the WC;
