The past nearly 20 years have taken on increased responsibilities in all areas of operations - managing aspects of facilities (including all repairs and maintenance), commercial finance/budget management, insurance, procurement/strategic sourcing, construction, IT infrastructure and telecommunication, event operations, VVIP security and logistics, corporate matters and contract management.

I can offer a unique combination of different skills in management, financial, analytical, organizational, communication, interpersonal, and administration, all of which are proven in successful operational efficiencies.

I am hands on yet nurturing in developing staff skills and allowing each to grow, proactive, able to work under pressure, learn new procedures quickly, adjust to the demands of irregular work schedules and can interact with management and peers alike.

I welcome challenges and am not afraid of hard work. It is important to know that above all, I work in a respectful manner and with the highest of morals and ethics.

I managed all aspects of operations, property and assets for multiple properties in Ottawa with a total portfolio valued at \$150M+. This includes one property that is leased to a federal crown corporation, so I am familiar with lease requirements and managing tenants.

All day-to-day tasks are focused on ensuring 100% operations and no failures of infrastructure and building systems, which includes compliance with all federal, provincial, and municipal regulations, and working closely with IT to develop and update business continuity and disaster recovery plans.

I routinely project managed capital projects ranging from \$100K-\$5M, dealing with architects, CM/GC and consultants. This includes developing work plans, timelines, milestones, budgets, and resource allocation and coordinating project Kick Offs, Planning, Schedule Updates, Change Management, Document Control, Postmortems.

Much of my previous role was also focused on environmental sustainability and reducing GHG. In this capacity, I co-chaired a global task force comprised of environmental focal points representing over 80,000 employees and nearly 50 profit and non-profit institutions/organizations.

I oversaw the development and implementation of standardized building guidelines, created a platform for sharing of best practices, developed strategic plans, developed training materials, and streamlining operations in the areas of energy, water, waste, transportation, facility management.

The commercial buildings I managed in Ottawa were cited for forward thinking and proactive initiatives in the areas of environmental sustainability and reducing GHG, including achieving ISO 14001 standards.

I am dedicated, passionate, driven in everything I do, and it is that enthusiasm that I would bring to the role. My professional experience has been complimented and enhanced by my volunteer activities – most recently as a Board Member with Children's Hospital of Eastern Ontario (CHEO) and Member of CHEO's Audit and Finance Committee.
