EQUESTRIAN CANADA EVENTING OFFICIALS ACCREDITATION PROGRAM ASSISTANT/SHADOW JUDGING WITH SENIOR OFFICIALS FOR PROMOTION

Shadow judging with a senior official and being evaluated is part of the evening officials certification program for Level 1 Three Event Day Judges and Eventing Jumper Judges.

For Three Day Event Judges - Shadow Judging is required for the Dressage and Show Jumping tests

For Eventing Jumper Judges – Shadow Judging is required for the Show Jumping test

1.1 THE PROCESS

The shadow judging program is self - directed and self- funded. The candidate sits with the appropriate licensed official at a competition..

Candidates wishing to undertake shadow judging with a senior official must:

- Contact and confirm participation with the suitable official and the reason for the request
- The senior official must meet the eligibility requirements (see 1.4 Matrix of Eligibility Requirements)
- The competition must meet the eligibility requirements (divisions hosted, timetable) (see 1.4 Matrix of Eligibility Requirements)
- Confirm the approval of the competition organiser
- Provide the mentor with the Shadow Judging Evaluation Report Form for the applicable test
- If the candidate is undertaking the show judging for purposes of promotion, an Application for Promotion must be filed with Equestrian Canada Officials Department

1.2 COMPLETION OF THE SHADOW JUDGING SUBMISSION OF THE EVALUATION REPORT

Within ten days of the shadow judging completion - The senior official will file the Shadow Judging Evaluation Report to Equestrian Canada- Officials Department and send a copy to the candidate.

The candidate is advised by Equestrian Canada Officials Department of the result and provided with information on any areas that have been identified "as needs improvement"

1.3 DEFINITION OF POSITIVE EVALUATION:

In order to be considered a positive evaluation - the candidate must receive a positive evaluation (indicated by meets or exceeds expectation) in all components plus an overall recommendation by the senior official.
