



FEI DOCUMENT REVALIDATION APPLICATION

Applications are treated on a first-come, first-served basis. Average processing time is 10 business days excluding shipping. Rush applications must be indicated on the outside of the package. Processing time begins once correct and complete information is provided to EC.

Remote FEI Revalidation Instructions

EC can provide FEI revalidation **WITHOUT** FEI documents being mailed in. Please include the following scans from the horse's FEI document with your completed application form:

1. Front Name Page
2. Ownership Page
3. Most recent equine influenza vaccination page(s)
4. Any warnings written by an FEI Official

EC will mail the FEI revalidation sticker (to be placed in the FEI document by the owner) once revalidation has been completed. All scans **MUST** be legible to process a remote FEI revalidation.
